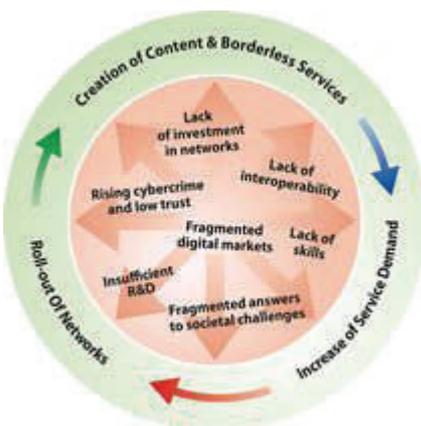

**Interoperability stands high in the new Digital Agenda for Europe**



Interoperability stands high in the new Digital Agenda for Europe, as demonstrated by the seven priority areas for action outlined:

- creating a Digital Single Market
- improving the framework conditions for interoperability between ICT products and services
- boosting internet trust and security
- guaranteeing the provision of much faster internet access
- encouraging investment in research and development
- enhancing digital literacy, skills and inclusion
- applying ICT to address social challenges such as climate change, rising healthcare costs and the ageing population.

The announcement for the new Digital Agenda for Europe identifies a raft of measures that will be put into place or proposed over the next 2-3 years, leading to follow-up actions up to 2015. The initiative will then evolve and develop over the next 10 years, as a flagship of the Europe 2020 Strategy to reach the 2020 targets. **Workshop on Scientific Base on Interoperability- IESA 2010- 15 April 2010, Coventry, UK**

The Greek Interoperability Centre co-organizes the "Scientific Base on Interoperability" Workshop within the frame of i-ESA 2010 Conference.

Interoperability is recognized as a high-impact productivity factor both within the private and the public sector, affecting the overall quality, yield time and cost of transactions, design and manufacturing operations or digital public services. Up to now, the principal tools for targeting the above challenges appear as the various standards that try to govern information systems development and operation. Such standards are usually linked with specific market sectors, application areas or technology trends, thus having a limited time span, a static nature and quite often different interpretations by technology vendors.

The workshop aims to address the issues of scientific formalization of Enterprise Interoperability, as a multidisciplinary research domain.

- Scientific methods for interoperability in specific sectors and vertical domains
- Impact assessment, simulation methods and tools
- Proposals on academic curricula on interoperability
- Proposals on marketing of the scientific offerings for enterprise interoperability.

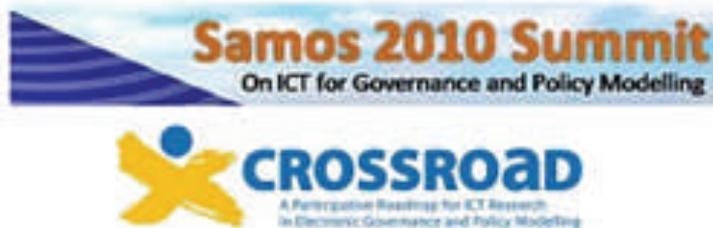
